For special district elections, who is an "eligible elector"?

The phrase "eligible elector" appears in special district election laws in several contexts. For example, eligible electors are the intended recipients of districts' call for nominations for Board Director elections. And, any Board Director candidate must meet the definition of an "eligible elector" in order to qualify to run for the office. But, what are the criteria to be an "eligible elector"?

Colorado Revised Statutes (C.R.S.) §32-1-103(5)(a) answers this question. An eligible elector is:

- » A person who is registered to vote in Colorado; AND
 - > A resident of the special district, OR
 - > An owner of real or personal taxable property within the special district.

Ownership of property becomes

significant when the person seeking to vote or seeking office, for example, is not a resident. In addition to the typical types of real or personal property ownership, there are a few additional types of ownership interests that are set forth in C.R.S. §§32-1-103(5)(a), (b), and (d):

- » Ownership by a person's spouse or civil union partner;
- » Obligations to pay taxes under a contract to purchase taxable property within the district boundaries or the area to be included within the districts; and
- » Ownership of mobile or manufactured homes.

To create the pollbook of eligible electors for a special district election, the district's Designated Election Official (DEO) requests both the list of registered electors

(from the County Clerk) and the property owners list (from the County Assessor) before the election. C.R.S. §§1-13.5-203, 1-13.5-204.

This answer shows us how important DEOs are to our special districts. Administration of elections requires adherence to election laws and careful planning. Remember, if your district needs additional training or information, SDA has worked with experienced DEOs and the Division of Local Government on webinars and resources for the upcoming May elections.
