Minutes of the Regular Meeting Of the Board of Directors Mountain Recreation Metropolitan District August 16, 2023

The regular meeting of the Board of Directors of the Mountain Recreation Metropolitan District, Eagle County, Colorado, was held on August 16, 2023, at 6:00pm, in the Edwards Field House, 450 Miller Ranch Rd, Edwards, Colorado, and via Zoom platform, in accordance with the applicable statutes of the State of Colorado.

1. Call to Order

The regular meeting of the Board of Directors of Mountain Recreation Metropolitan District was called to order by Director Erickson on August 16, 2023, at 6:00pm, noting a quorum was present to conduct business.

2. Changes to the Agenda

Director Erickson asked for an Eagle pool project update. Mr. Ruff stated that staff recently met with architects for a walk-through of the Eagle facility. Director Erickson requested that an Eagle pool project update be placed on every meeting agenda moving forward. Ms. Owens stated that the District had applied for a grant through Great Outdoor Colorado (GOCO) but was not moved into the next stage of the process. Ms. Owens and Mr. Nycum have scheduled a meeting with a GOCO representative to explore more grant opportunities regarding the Eagle pool project.

3. Approval of Minutes

Director Erickson asked the board to consider the July 19, 2023 meeting minutes.

Director Erickson moved to approve the July 19, 2023 meeting minutes as presented. Director Kerwin seconded the motion. It was unanimously

RESOLVED to approve the July 19, 2023 meeting minutes as presented.

4. Public Input

Director Erickson asked for anyone from the public wishing to share comments with the board to do so at this time.

There was none.

5. Presentations

a. ECO Trails Presentation

The Mountain Recreation Foundation entered into a fiscal sponsor agreement with Eagle Valley Trail in December 2022. Ms. Owens provided the board with an update on the successful relationship between the Mountain Recreation Foundation and Eagle Valley Trail. Ms. Owens explained that all donations are processed through Mountain Recreation Foundation's website or by check. The process ensures that every donor learns about the Mountain Recreation Foundation during each transaction and acknowledgment. Ms. Owens stated that once the Eagle Valley Trail campaign is completed, the Mountain Recreation Foundation will have access to all donor information allowing further communication with them regarding the foundation's efforts. Ms. Owens reviewed the current amount of funds raised and the plan to complete the fundraising campaign in 2024.

Director Kerwin asked for more details about credit card processing fees. Mr. Timilsina confirmed that Eagle Valley Trail is responsible for the credit card processing fees. Kevin explained that Eagle County will install a kiosk along the trail with Mountain Recreation branding to acknowledge the District's support. Mr. Nycum asked which section of the trail was undeveloped. Mr. Sharkey confirmed that the goal is to develop the area between Edwards and Wolcott. Mr. Erickson asked how the future Wolcott development will affect the trail. Mr. Sharkey explained that a paved trail next to a residential development will be valuable considering the future bus stops.

6. Business

Staff requested direction from the board on several items used to help build the FY 2024 budget and one request on the FY2023 budget.

- i. FY 2023 & 2024 FT Wellness Benefit
- ii. FY 2024 Compensation plan

i. FY 2023 & 2024 Full Time Wellness Benefit

In November 2020, the board approved the expenditure of FY 2020 & 2021 funds for a wellness benefit, affording full-time staff the opportunity to purchase wellness, mental health, exercise, or other health-promoting items. The benefit provided to full-time staff was \$800. Qualified part-time staff, those who worked an average of 20 hours or more per week over the previous six months, received a \$400 benefit.

The approved motion in the November 2020 board meeting did not specify if the wellness benefit should be extended beyond FY 2021 so staff did not include the benefit in the FY 2022 budget. In November 2022 the board approved the wellness benefit for the FY 2022 budget. Due to a tight FY 2023 budget, staff opted to remove it from the budget to help accommodate new full-time position requests.

Mr. Robinson explained that if the board approves the wellness benefit in FY 2023 and beyond, the District can use it as a recruitment tool in job postings. He stated that the cost is expected to be approximately \$30,000 in FY 2023 and is estimated to be the same amount in FY 2024 and beyond. Director Pohl explained that the amount of \$800 was chosen because it is similar in value to what local organizations provide as free ski passes to their employees. Discussion ensued between the staff and board members about the purpose of a wellness benefit and if there should be proof of receipt to receive it. Staff shared that wellness has a different meaning to each individual and staff do not want to place any barriers on the benefit. Mr. Nycum voiced his support for the wellness benefit and stated that he believes it will be a good recruitment and retention tool. Director Erickson asked Mr. Timilsina if there is room in the FY 2023 budget. Mr. Timilsina confirmed that it can be included in the FY 2023 budget. Director Cowles voiced his concern about potentially excluding seasonal employees with the hourly requirement. Mr. Robinson stated that staff will review the part-time hourly requirement and make sure all employee groups are given an opportunity to qualify for the wellness benefit.

Director Pohl moved to approve the employee wellness benefit for FY 2023 and future years. Director Edwards seconded the motion. It was unanimously

RESOLVED to approve the employee wellness benefit for FY 2023 and future years.

ii. FY 2024 Compensation Plan

Throughout the years, the District has traditionally completed compensation studies internally, using Employers Council surveys and contacts at local recreation districts, primarily on the Western Slope. In 2018, the board provided direction to ensure the District's pay strategy focused on keeping wages in line

with current market rates to ensure staff have the financial resources to attract and retain top talent.

Mr. Robinson explained that in May 2023, Cat Olson (former HR Manager) researched cost of living adjustment (COLA) and saw it trending around 3%. Based on last year's board direction to include merit increases, the management team recommended using a 5% salary and wage increase for the FY2024 draft budget which accommodates a 3% COLA and up to 2% merit for staff. Mr. Robinson stated that the current consumer price index in August 2023 showed that the COLA projection is now 4.5%. Staff recommend moving forward with the 3% COLA and up to a 2% merit increase.

Director Erickson voiced his concerns with the percentage split between COLA and merit. He stated that he would prefer to see the merit increase be more impactful. Discussion ensued regarding pay compression and COLA versus merit increases. Director Edwards voiced his support for the proposed compensation plan and expressed that offering wages above market value in future years could serve as a recruitment and retention benefit. The board gave direction for staff to continue FY2024 budget planning with the proposed compensation plan while understanding that the numbers can be adjusted in October.

iii. 2024 Capital Improvement Plan

Staff has completed work on the review of capital projects for FY 2024. The budget includes vehicle and equipment replacements (VERP), contributions to shared capital replacement funds, and funding for capital replacements for those facilities not covered by jointly managed replacement funds (sports complexes, field house, and park spaces).

Mr. Ruff explained that the District would like to retire the Chevy Malibu and purchase a new vehicle and snowplow kit. He stated that the capital fund contributions will remain the same at \$50,000 to both Town of Eagle and Town of Gypsum. He reviewed the planned expenses, such as shade structures, for Wildcat Park and the Eagle Sports Complex. He stated that the Edwards Field House will have multiple improvements including indoor turf replacement, gymnastics enhancements and the roof repainting project. Mr. Johnson explained that staff met with Berry Creek Metro District to request funding for the roof repainting project, and they will discuss the decision in the fall.

Mr. Timilsina stated that revenue is favorable to the budget due to investment income, Gypsum Rec Center membership revenue, and Edwards Field House

facility rentals. Mr. Timilsina explained that Outdoor Rec is unfavorable due to program cancellations and part-time staff wages being higher than anticipated due to full-time staff injuries.

Director Cowles moved to approve the financial statements and accounts payable report as presented. Director Kerwin seconded the motion. It was unanimously

RESOLVED to approve the financial statements and accounts payable report.

Mr. Robinson gave an update on the HR manager hiring process. Mr. Ruff stated that concession services are covered for the remainder of the season and request for proposals will be sent out next year for the concessionaire spot at the Eagle Sports Complex. Mr. Robinson shared Ms. Owens's plan for recruiting and increasing the number of volunteer coaches.

9. Reports & Board Communication

Mr. Nycum confirmed details of the board retreat which will take place on September 11th from 12:00 pm - 5:00 pm and will replace the regularly scheduled board meeting which was scheduled for September 18th. Mr. Nycum and board members decided that a second board retreat will take place on October 2nd if necessary. Ms. Owens reminded staff and board members of the upcoming sports gear swap and Fiesta Americas.

10. Adjournment

Director Pohl moved to adjourn the board meeting. Director Edwards seconded the motion. It was unanimously

BACKGROUND:

Mountain Rec recognizes the value of recreational programs, services, and facilities to instill strong and positive character in young boys and girls, ensure a lifetime of health and happiness for all ages, and reduce social isolation by creating connections across the community. Recreational activities can help a person learn important life lessons, such as how to work hard, persevere, be a team player, set goals, follow rules, and stay healthy for a lifetime. Toward this end, the Mountain Rec Board offers qualified organizations the opportunity to apply for financial assistance through the Community Partnership Grant Program.

In 2021, the Community Partnership Grant Program was reimagined to include Healthy & Happy In-Kind Grants. The applicants should consider how the proposed program or service aligns with Mountain Rec's Strategic Plan; alignment with the District's mission, vision, and strategic plan will strengthen the application. In-kind funding is available only to those programs/events/services that are not currently conducted by Mountain Rec or in a partnership with Mountain Rec. The Board earmarked \$15,000 to be used in in-kind grant funding to our partners in 2023.

In March 2023, the Board approved moving the Community Partnership Grant Program to an annual cycle to be presented before Mountain Rec's approved budget. This allows even more opportunity to help local nonprofits serve our community as Mountain Rec can match the

budget numbers to the approved requests from the community, allowing nonprofits to manage their budgets more effectively and ensuring greater access to Mountain Rec's facilities, programs, and services.

In-kind funding \$1,326 is available for the rest of FY23. Eight of the fourteen applicants are new to the Community Partnership Grant Programs; two requests are for FY23 only and the rest are for FY24 or a combination of FY23 and FY24.

All requests are considered in relation to eligibility requirements; all applicant organizations must:

- Offer programs or services that are recreational in nature or conduct improvement projects that expand or enhance recreation opportunities in the District.
- Serve Eagle County as evidenced by (1) at least 80% of program participation coming from Eagle County or (2) propose projects directly benefiting and accessible to Mountain Recreation District residents.
- Offer programs or projects that are available to everyone equally, with open participation
 or involvement that is not restricted by diversity factors such as race, ethnicity, religion,
 ability, skill, or financial ability to pay; and
- Be registered in good standing as a Colorado nonprofit organization with the Colorado Secretary of State and have 501(c)3 status.

BUDDY WERNER LEAGUE

Request for FY 2023: Ski conditioning class for up to 50 adult coaches and 30 junior coaches to be planned and executed by Gypsum Rec Center staff for six weeks in October and November; Gypsum Rec Center memberships for the 80 coaches for winter months. The total for Buddy Werner League's full grant request in FY 2023 is \$8,850.

Buddy Werner League (BWL) is an affordable youth recreational ski racing program for children in grades two through eight; 85% of BWL families are local to Eagle County. Teams ski with volunteer and junior coaches for a ten-day season which includes three race days and a chance to compete in the BWL state race. BWL is a volunteer ski program that helps local children learn the techniques of ski racing to improve their overall skiing and athletic abilities, all under the guiding principles of good sportsmanship, integrity, commitment, hard work, and teamwork for which Buddy Werner was known.

BWL requests

- Twice a week ski conditioning class created, planned, and executed by Gypsum Rec Center staff.
- Membership passes to 50 adult coaches and 30 volunteer coaches.

DISCUSSION:

BWL is a first-time applicant and offers recreational activities that Mountain Rec currently does not. The mission and the community that BWL serves align with Mountain Rec. The ski conditioning class is a unique ask and falls within the scope of the grant program. Due to time constraints and scheduling issues, it is not feasible to offer this class in 2023.

The cost for the passes for 80 people for one month comes to \$3,860. This is a very high cost for one month for individuals who may or may not use the facility or who may already be members.

RECOMMENDATION:

Staff recommend that the Board awards BWL a once-a-week ski conditioning class for a maximum of 20 people to be held in FY 2024 and to be open to the public once BWL coaches have had early registration opportunities. **Total grant award recommended to BWL in FY 2024:** \$2,350.

Staff does not recommend monthly membership passes to the Gypsum Rec Center.

EARLY CHILDHOOD PARTNERS

Requests for FY 2024: Eight family passes to a Gypsum pool, 50 individual pool passes at both Gypsum Creek Pool and Gypsum Rec Center Pool, two pool parties, a gymnastics party at Gypsum Rec Center, eight family annual passes at Edwards Field House, a gymnastics party at Edwards Field House, and 50 individual pool passes at Eagle Pool. **Total for Early Childhood Partners' full grant request in FY 2024 is \$1,862**.

Early Childhood Partners' mission is "serving the community by creating an educational and social emotional foundation in which children thrive." Early Childhood Partners (ECP)

specializes in supporting young children, families, and early childhood caregivers through comprehensive programs and approaches that strengthens the well-being of families, and addresses disparities in the social determinants of health. ECP's Family Support Services include: Parenting Classes in English and Spanish (four separate, fourteen week sessions throughout the year free of charge with dinner and childcare provided); ECP's Family Resource Center; Home Visitation through Promoting Supporting Safe and Stable Families Case Management; Early Childhood Mental Health Consultation; Counseling services for families who cannot otherwise access treatment due to language barriers or financial limitations; Circle of Security Parenting (which focuses on the development of safe, secure relationships and attachment); and Lena Home, which focuses on language development and increased interaction between children and their caregivers. All ECP's programs are offered free of charge in both English and Spanish, and most families participating in ECP's family support services need help with getting basic needs met in addition to parenting support.

If granted, ECP will be able to use the pool passes, pool parties, and field house passes to incentivize consistent participation in our evidenced-based parenting classes and family support programs. By offering families participating in our programs pool and recreation center passes, we have no doubt that young children and their caregivers will have increased access to physical activity, social connections, and opportunities to experience shared moments of joy in community settings, which are foundational to safe and healthy relationships. The families that will benefit from Mountain Recreation's in-kind donations would likely not be able to afford access to the pools, Recreation Center, or Edwards Field House otherwise.

DISCUSSION:

ECP is a local nonprofit whose mission aligns with that of Mountain Rec. ECP is dedicated to ensuring local families are healthy and happy in childcare and with a wide range of parenting trainings with a focus on underserved portions of the community. The gifts requested will aid ECP in increased attendance in parenting classes and will introduce some families to Mountain Rec.

RECOMMENDATION:

Staff recommend awarding some of the requested in-kind gifts to commence in FY 2024: From the Gypsum Rec Center, awarding eight (8) family day passes (\$256), one gymnastics party for 15 (\$225), and one pool party for 15 (\$125); from Edwards Field House, awarding eight (8) family day passes (\$256) and one gymnastics party (\$225). **Total grant award recommended to ECP in FY 2024: \$1,087**

FAMILY LEARNING CENTER

Requests for FY 2024: Swim lessons provided by staff teachers to FLC children, a family engagement activity for up to 120 children and adults at the Eagle Ice Rink, staff team-building time at the Edwards Field House's community room, a field trip for the toddlers to attend Tumble Tots, use of Edwards Freedom Park for preschool field day usage, use of the community room for staff training in the Gypsum Rec Center, a family engagement activity for up to 120 children and adults in the Gypsum Creek Pool or Gypsum Rec Center Pool, and two 20-visit punch passes. The total for FLC's full grant request in FY 2024: \$2,555.

Family Learning Center's (FLC) mission is "serving the community by creating an educational and social emotional foundation in which children thrive." FLC is focused on two major impact areas in 2023 and 2024: creating monthly family engagement activities for staff and families to

build community and staff retention and team building, which significantly helps in staff retention and the comfort of the children.

FLC would use any in-kind gifts for team building and community building for the FLC families and staff.

DISCUSSION:

Family Learning Center is a repeat CPGP applicant, is the largest CCAP provider in Eagle County, and provides childcare for many local underserved children. All students come from Eagle County, and these grant requests may provide children and families the opportunity to learn more about Mountain Rec and our services, programs, and facilities.

RECOMMENDATION:

With the Eagle Pool out of service for the summer of 2024, all Eagle Pool requests are denied. Mountain Rec does not typically give items like the 20-visit punch passes for auction fundraisers through the CPGP; it is recommended that FLC reach out once their auction is approaching for items.

Community room usage in the Gypsum Rec Center and Edwards Field House is free for qualified nonprofits, which FLC is. Use of Edwards Freedom Park during the day is also free for qualified nonprofits.

Staff recommend granting the Tumble Tots field trip for two groups of 16 each to accommodate the 32 children. Other restrictions include having the field trips take place between 1pm-3pm due to other gymnastics programming (\$428). Staff recommend granting the Gypsum Creek Pool party with a maximum of 80 people (\$595). Staff recommend granting the Eagle Ice Rink family engagement activity for 120 children and adults (\$1,052). **Total grant award recommended to FLC for FY 2024: \$2,075**.

GYSPUM ELEMENTARY SCHOOL

Requests in FY 2024: Two to three gymnastics sessions in Gypsum Rec Center for second and third grade students and swim sessions/lessons for second and third grade students. **The total for Gypsum Elementary School's full grant request in FY 2024: \$315**

Our mission, at Gypsum Elementary School, is to provide multiple movement opportunities for our students and community. We believe in providing learning toward a goal of lifelong fitness. Our hope, is then, for those students to introduce these opportunities to family, community, and future students.

DISCUSSION: Gypsum Elementary School is covered under the IGA with the Eagle County School District. While use of facilities is included in the IGA, staff time is not. Offering gymnastics sessions for students introduces them to new athletic endeavors and possibly the Gypsum Rec Center. GES is a Title 1 school, and staff believe this would be beneficial to the students.

RECOMMENDATION:

Staff recommend not offering swim lessons due to the aquatics supervisor not starting until the end of September and because of aquatics staffing shortages. Staff recommend awarding three gymnastics sessions to three groups of 15 of second and third grade students between the hours of 1pm and 3pm. **Total grant award recommended to Gypsum Elementary School:** \$315.

HABITAT FOR HUMANITY VAIL VALLEY

Request for FY 2024: 10 days of Rec Kids camps for 5-7 children throughout the summer. **Total** request from Habitat for Humanity Vail Valley in FY 2024: \$3,000.

Habitat for Humanity Vail Valley (Habitat) is a nonprofit affordable housing developer. Through our home building efforts, we increase access to safe, affordable housing in Eagle County and make a direct positive impact on the financial stability of our homeowners as well as the overall community. Our vision is a world where everyone has a decent place to live. Habitat works toward our vision by building strength, stability, and self-reliance in partnership with families in need of decent and affordable housing. Our mission is to build homes, community, and hope.

Habitat partners with families to build a place they can call home. Partner families put in 250 hours of sweat equity per adult on the construction of their home and take first time homebuyer and self-sufficiency classes. Often, this is a challenge for partner families as they are unable to afford childcare while they work to meet these requirements. Mountain Recreation has quality childcare offerings that would not only alleviate the pressure for these families but would also provide increased access to developmentally appropriate recreation while the partner families work on their sweat equity hours and self-sufficiency classes.

DISCUSSION:

Mountain Rec believes everyone deserves to be healthy and happy; that includes having shelter. This is Habitat's second application; their first application was granted, which was similar in scope to this request. Habitat is a qualified non-profit applicant, has a mission and vision that are aligned with Mountain Rec, and serves a broad range of community members. However, offering Rec Kids to home builders would benefit the community and possibly introduce Mountain Rec to new families.

RECOMMENDATION:

Staff recommend that the Board offer Rec Kids camps at a location and on dates determined by Day Camps & Senior Supervisor alongside the Habitat staff with ample notice to six kids for ten days throughout summer 2024 (one day of Rec Kids is \$50; ten days at \$50 is \$500; six kids at ten days is \$3,000). **Total grant award recommended to Habitat for Humanity in FY 2024:** \$3,000.

MOUNTAIN VALLEY HORSE RESCUE

Request for FY 2023: Annual family pass at Gypsum Rec Center to be auctioned off in September 21 fundraiser. **Total for MVHR's ask for FY 2023: \$1,111.**

Mountain Valley Horse Rescue (MVHR) is committed to rescuing, rehabilitating, and rehoming abused, neglected, abandoned, and unwanted equines. MVHR also works to reduce cases of

equine abuse and neglect through community education and outreach. MVHR also offers ample volunteer opportunities for community members to work with horses and they offer camps during the summer for children to learn how to care for equines.

MVHR is asking for one annual family membership to the Gypsum Rec Center to auction off in their annual fundraiser where all funds go toward helping horses.

DISCUSSION: Mountain Valley Horse Rescue is a first-time applicant and is a qualified nonprofit serving the local community which Mountain Rec regularly partners with in Outdoor Recreation programs to demonstrate the wide range of outdoor recreation opportunities. While MVHR is focused on helping horses, their volunteer and summer camp programs are robust and offer a different kind of recreation to those who participate. Offering this award would likely demonstrate Mountain Rec's support of a wide range of recreational activities and populations who enjoy different ways to recreate than what we currently offer. Typically, Mountain Rec does not grant items to auction off in the CPGP, however, this is a substantial ask from a first-time applicant that does exceptional work within the community. Additionally, this is an item that can be awarded in FY 2023 as their silent auction is on September 21, 2023.

RECOMMENDATION: Staff recommend awarding MVHR one annual family pass in FY 2023. Total grant award recommended to MVHR in FY 2023: \$1,111

MOUNTAIN YOUTH

Requests in FY 2024: Various; please read below. **Total request for Mountain Youth in FY 2024:** \$9,683.

The mission of Mountain Youth is to continuously and collaboratively improve the lives of youth in the most powerful ways possible.

Mountain Youth kindly requests in-kind support for our youth, family, and community education efforts, specifically the Valley's Voice, Tu Guia, Eat/Move Chat Connect and Aprendiendo Juntos programs. All efforts of Mountain Youth are intended to serve the local 9-25 youth community, as well as their parents/caregivers, trusted adults, and community members. The Valley's Voice youth leadership and advocacy program provides opportunities for youth to connect with their peers in positive, prosocial settings that are open to all middle and high school youth in the community. The goal of the program is to provide youth with a voice in community decisionmaking and encourage youth to choose positive health behaviors when connecting socially. The Tu Guia program is a near-peer academic and mentoring program that connects a high school tutor with elementary youth to support and improve their social skills as well as reading and math skills, helping them return to grade-level scores, and connect more socially with their peers. Families are also asked to attend the Eat Chat Connect or Aprendiendo Juntos (Learning Together) education series to increase their knowledge and skills that will support their child academically, socially, and their overall behavioral health. Both series focus on providing culturally and linguistically relevant (English or Spanish) behavior health education with expert presenters, with a goal of reducing behavioral health stigmas and improving conversations in the community and in the home. Move Chat Connect builds on the education series by connecting physical and mental health and giving families an opportunity to do something

active and learn from a behavioral health expert on how doing this together as a family improves overall individual and family health significantly.

Move Chat Connect

Move Chat Connect (MCC) is looking to create more inclusive and active events so all families have equal access to movement and sport. We are asking for in-kind support for the cost of the ice rink and skate rentals for 150 people for a **total of \$1,052**.

<u>Tu Guía/Your Guide</u> is a youth-led and adult-supported program for local high school students to tutor elementary students from all K-5 schools in Eagle County and some middle school students who may need academic assistance. Tu Guía would like to offer students and their families a celebratory event that provides a new experience for all. Tu Guía would like to offer an ice-skating party for 50-100 people plus rentals (\$752). Tu Guia would also like to request an Edwards Field House rental including use of the community room, anti-gravity center, and turf field for a celebration with approximately 50-100 people (\$500). **The total request for Tu Guía is \$1,252**.

Aprendiendo Juntos/Learning Together supports our Spanish-speaking community through inperson discussions in Spanish on topics including behavioral health, childcare, education, economic assistance, and more. At our most recent skating event, women who attended expressed a very clear interest in having access to fun, engaging, movement opportunities. In 2024, Mountain Youth would like to provide more opportunities for AJ families, particularly women, in the form of ice-skating lessons and other fitness activities. Once these women establish a wellness pattern, we believe they will access Mountain Rec opportunities on their own. We are asking for two-three ice skating lessons for 35 adults plus skate rentals at the Eagle Ice Rink (\$1,292-\$1,938) and a Zumba class in the Gypsum Rec Center for Aprendiendo Juntos and Move Chat Connect Parents (\$115) The total for Aprendiendo Juntos is \$2,053

Valley's Voice

The Valley's Voice program supports and enhances youth leadership and advocacy skills, opportunities, and partnerships that create positive changes in the community to improve the health of youth. All health advocacy topics are identified by youth, efforts and solutions are led by youth, and outcomes are driven by youth through support and partnership with adults. Youth have identified safe and positive spaces as a priority area to focus and plan prosocial and substance free activities for their peers. In 2022 and 2023, activities and spaces were identified by youth and have been offered in partnership with Mountain Rec. For 2024, Mountain Youth wants to continue to support their endeavors and this partnership and is asking for two open field/activity nights/full facility rentals for at the Edwards Field House including the community room, eSports room, turf field, and sports court, plus one additional activity with either climbing (\$670) or the anti-gravity center (\$890). Valley's Voice is also requesting use of the Gypsum Rec Center with waived entrance fees for up to 75 middle and high schoolers (\$525). Additionally, they are requesting one after-hours full facility rental from 9pm-midnight for all local high schoolers (\$2,500). The total from Valley's Voice is \$4,585.

Punch Passes

Mountain Youth requested a total of 60 passes for two people to use together which comes to a total of \$741.

DISCUSSION:

Mountain Youth is a qualified non-profit applicant, has a mission that is aligned with Mountain Rec, serves local youth, and is a strong, long-time partner of Mountain Recreation. Nearly all the requests are feasible and reasonable and offer recreational opportunities to our partner, though

with staff shortages in aquatics and the ice rink, some requests may not be timely. In the previous grant cycle, passes were granted to Mountain Youth to encourage people to come together—none have been used at this point. This is a significant combined ask of Mountain Rec.

RECOMMENDATION:

Staff recommends granting the MCC request of an ice-skating event for up to 150 people (\$1,062), the Edwards Field House rental for Tu Guía (\$500), and one Zumba class at the Gypsum Rec Center for Aprendiendo Juntos and MCC parents (\$115). For the Valley's Voice program, staff recommends one Edwards Field House with the climbing tower (\$670) and one after-hours full facility rental (\$2,500). **Total grant award recommended to Mountain Youth in FY 2024: \$4,847**.

THE CYCLE EFFECT

Requests in FY 2024: Twice-weekly practices in designated space in Edwards Field House for thirteen weeks between January and April 2024 (\$1,040), a celebration/recruitment event at the Eagle Ice Rink (\$604), and a celebration/recruitment event at the Gypsum Creek Pool for a max of 80 people (\$595). **Total for The Cycle Effect's grant request in FY 2024: \$2,239.**

The Cycle Effect's (TCE) Girls Mountain Bike Program is offered after-school year-round to Latina, BIPOC, and/or low-income young women in 5th-12th grades. In 2023, we anticipate serving roughly 65 girls on our Edwards team, 65 girls on our Eagle team, totaling 130 in Eagle County, with 70% of young women in our program identifying as BIPOC and/or Latina, and 70% as low-income. We also aim to serve over 250 youth with mini-clinics and partnering with local schools and organizations.

The Cycle Effect requests full in-kind use of the Edwards Fieldhouse to conduct two practices per week on Mondays from 4:00 pm- 5:30 pm and Wednesdays from 4:00 pm-5:30 pm in a designated space/room/field from January 23rd to April 26th, 2024. The Edwards Fieldhouse is an ideal location for participants on the Edwards Team that reside up valley. Most of our participants' parents work multiple jobs and late hours that do not allow them to pick up their children after school and drive them to faraway programs that start immediately after school. This facility's use will help provide a convenient location for girls to access while taking part in our after-school program focused on strength training until the mountain bike season officially begins. The use of the Edwards Fieldhouse is crucial to our programming and will allow our participants to utilize an indoor facility.

In addition to this, The Cycle Effect would like to make the following in-kind request if deemed appropriate and available:

- Ice Skate celebration recruitment event at the Eagle Pool and Ice Rink
- Two-hour access to Gypsum Creek Pool for summer recruitment and celebration

DISCUSSION:

The Cycle Effect (TCE) is a qualified nonprofit that serves Latina, BIPOC, and/or lower-income girls between 5th and 12th grades by offering mountain biking. TCE is a long-time partner of Mountain Rec, demonstrated by multiple Mountain Rec-TCE mountain biking camps held this

past summer. Mountain Rec has granted this request from TCE before and understands that it is a significant help to their budget. Celebrations and recruitment events are vital for the sustainability of organizations but due to current staff shortages in the ice rink, a Gypsum Creek Pool event in nearly a year seems more manageable for staff.

RECOMMENDATION: Staff recommend award the Edwards Field House in-kind use (\$1,040) and the celebration/recruitment event at the Gypsum Creek Pool (\$595). **Total grant award recommended in FY 2024 to The Cycle Effect: \$1,635.**

THREE RIVERS LITTLE LEAGUE

Request in FY 2024: Edwards Field House: discounted/free turf field rentals in the Edwards Field House plus associated staff time for three assessment sessions in February/March 2024. **The total request from TRLL in FY 2024 is \$2,270**.

Three Rivers Little League instills in every player the ideals of good sportsmanship, honesty, loyalty, courage, and respect for their families, community, and team. It is our goal to teach every player the game of baseball/softball and the skills to succeed in playing it.

Three Rivers Little League would like to request discounted or free rental fees at the Edwards Fieldhouse. We host 2-3 events that are currently scheduled for February and March 2024. It would go a long way to not have to pay fees to rent the facility those days. Those are reserved for assessments of our prospective players and coach/umpire clinics.

DISCUSSION: TRLL is a qualified nonprofit that serves a wide region including the Roaring Fork Valley, Carbondale, Glenwood, Aspen, Basalt, and Eagle Valley. One of the eligibility requirements for the CPGP is serving Eagle County where at least 80% of program participation comes from Eagle County or proposes a project directly benefiting and accessible to Mountain Recreation District residents. While 40% of all players in TRLL hail from Eagle Valley, the Edwards Field House rentals would be used by a group 98% from Eagle Valley.

RECOMMENDATION: Staff recommend an in-kind grant of staff fees for the three assessments held in Edwards Field House. **Total grant award recommended to TRLL in FY 2024 is \$455.**

VAIL SKI & SNOWBOARD ACADEMY

Request for FY 2024: discounted fees for Wilderness trips. **Total request from VVSA is anything up to \$4,500**.

Vail Ski and Snowboard Academy (VSSA) provides a rigorous college preparatory academic program while supporting the athletic and personal goals of our students. In partnership with Ski & Snowboard Club Vail, other elite clubs, and Eagle County Schools, VSSA facilitates the attainment of our students' dreams by offering challenging academics, flexible scheduling, individualized attention, and access to world-class training.

Mountain Rec is doing two backcountry trips with VSSA for our wilderness trips. We are excited to do this with them this Mountain Rec this August. If any of that cost could be in-kind to reduce the cost to the school and our budget, that would be awesome. Honestly, we would rather see higher-need schools receive scholarship benefits if funds are limited. Wilderness is a chance for

our kids to get to know each other and build relationships and teamwork with each other in a fun setting outside of school. VSSA requests discounted fees for Mountain Rec-led Wilderness trips which give the students opportunities to connect and build community.

DISCUSSION: VSSA is a small 5th-12th grade school (260 students for the 2022-23 academic year) in Minturn with almost all students hailing from Eagle County. It is accessible to all Eagle County students as it is a part of ECSD. The Wilderness trips do not fall under the IGA and offer a unique way for the students to connect through a safe and fun experience hosted by Mountain Rec.

RECOMMENDATION: Staff recommend granting a discounted fee for the 2024 Wilderness Trips. Total grant award recommended to VSSA for FY 2024: \$500.

VAIL VALLEY LACROSSE CLUB

Request for FY 2023 and FY 2024: Edwards Field House turf rentals from November 2023-March 2024 for:

- Youth lacrosse clinics for one hour two times a week
- Youth cross-training programs for one hour one time a week
- Adult pick-up games for one hour one time a week

Total amount of full request in FY 2023: \$3,225; total for FY 2024: \$7,740. Total for full ask: \$10,965.

The Vail Valley Lacrosse Club would like to continue to provide off-season programs utilizing the Edwards Field House Turf during the months of January, February, March, November, and December. We are requesting in-kind support of the indoor field rental cost for our winter programing. VVLC will offer youth Indoor Lacrosse Clinics, and youth Cross Training programs as well as an adult pick up night. We feel fortunate to have such a great facility located centrally in our community to host indoor field sports. All youth programming will be available to Eagle County boys and girls from 2nd grade - 8th grade, and adult available to anyone over 18 years old. Each session of these programs will be scheduled for 1 hour per group. The drills, training and play are designed to keep participants physically active throughout each session with appropriate rest and water breaks. All youth sessions will be facilitated and instructed by paid and/or volunteer coaches. The Lacrosse Clinics will be scheduled two days a week while the Cross Training and Adult pick up scrimmages will be scheduled one day a week. The Clinics and the scrimmages will be specific to the sport of lacrosse; however, the Cross Training program would be open to athletes from other sports as well. The Cross Training program will focus on improving an individual's speed and agility that can translate to any sport. Registration will be month to month, for each program.

We would use the in-kind services to help offset the field rental cost to continue to provide these programs as options to our community. Unfortunately, between the cost of the rental fees and labor cost, these winter programs struggle to break even each month. With the support of the CPGP we can easily continue to provide the programs and maintain low registration fees, add coaches, or even add additional opportunities. Increased coaching staff during each session helps provide efficient and productive sessions and can allow us to increase participation numbers. We work hard to keep program fees low and offer discounts or scholarships when needed to be accessible to anyone who is interested.

The Vail Valley Lacrosse Club is thankful to have a great partnership with Mountain Recreation and look forward to strengthening that relationship even more thorough additional opportunities.

DISCUSSION: VVLC is a qualified nonprofit and repeat applicant that offers recreational activities that complement those of Mountain Rec. VVLC is a longstanding partner of Mountain Rec, as evidenced by camps and clinics offered throughout the year. Field turf rental costs for winter programming are a reasonable request, though when the full cost of the request is examined, it is significant. Mountain Rec recently went through facility rental rates to help with increased costs due to inflation and general maintenance costs.

RECOMMENDATION: Staff recommend granting one hour/week of staff time to VVLC on Sundays for 17 weeks in FY2024. *The total for VVLCs full grant request in FY 2024: \$595*.

VAIL VALLEY SOCCER CLUB

Request in FY 2024: Edwards Freedom Park in-kind use for Vail Cup in October 2024. **Total request for Vail Valley Soccer Club in FY 2024:** \$6,650.

The Vail Cup is a soccer tournament that occurs the first weekend of October in the Vail Valley. This year the Vail Cup is expanding again, up from its previous largest tournament to 161 teams for 2023. We are interested in sponsorship support for next year's tournament Mtn Rec/Freedom Park field use for the 2024 event. Each year teams travel from within the state of Colorado and surrounding states to play soccer in our picturesque community. The Vail Cup utilizes soccer fields from Vail Mountain School to the town of Eagle. The tournament also occurs during a traditionally slow time of year, filling the valley's hotels, restaurants and shops with families, players, and coaches. The Vail Cup has been running for 20 years. The Vail Cup soccer tournament supports our scholarship player program and our programming. Over 60% of our scholarship funds come from this tournament which is our largest fundraiser of the year. Many local soccer kids would not be able to join the soccer club without this financial support. We are proud of the diversity of our club and the opportunities it provides the entire club membership. Many players might not otherwise continue playing or would not play at the level the club provides. VVSC players travel in and around Colorado to games and participate in several tournaments out of state. For some players this gives them an opportunity to be seen by college coaches, if they have an interest in pursuing college play, after they leave high school. We, as a club, continue to work towards new and improved programming for our players and continued extra support for our coaches in respect to them furthering their coaching credentials. Monies supported through sponsorship and grants also help us continue with new and innovative programming within our club.

DISCUSSION: Vail Valley Soccer Club is a qualified nonprofit that offers recreational opportunities that complement Mountain Recreation's offerings. A full one-third of their program participants receive financial assistance, demonstrating the inclusive nature of the program. The Vail Cup is a large tournament, bringing in an estimated 10,000 people to the region, all of whom pay fees for the tournament. Mountain Rec recently reexamined its field rental fees for local organizations and determined that due to inflation and increased costs across the board, the organization needed to increase rental fees for tournaments.

RECOMMENDATION: Staff recommend an in-kind grant for a portion of the field rentals for the Vail Cup in October 2024. The total grant award recommended to VVSC for FY 2024 is \$500.

VAIL VALLEY UNBOUND

Requests for FY 2023 and FY 2024: Edwards Field House to use for PE classes 2-3 times a week from November through April (full turf field: \$8,250; half turf field: \$4,500; sport court: \$2,650) and Edwards Freedom Park to use for PE classes 2-3 times a week from April through June: \$0. Total request from Vail Valley Unbound for FY 2023: \$1,650 (full turf), \$900 (half turf), or \$525 (sport court); total request from Vail Valley Unbound for FY 2024: \$6,600 (full turf), \$3,600 (half turf), or \$2,125 (sport court).

Vail Valley Unbound is a new innovative elementary school based in Edwards. Their mission is: "We are a learner-driven community that aims to inspire, facilitate, and guide our young learners to find their calling and maintain a lifelong love of learning."

At Vail Valley Unbound, we believe that physical education is not just a subject; it is a life-long journey. By exposing learners to a diverse range of physical activities, from traditional sports to fitness-oriented exercises, we are empowering them to discover their passions and interests. By fostering a love for physical activity, our students are more likely to pursue active and healthy lifestyles.

DISCUSSION: Vail Valley Unbound (VVU) is a first-time applicant and is a new school to Eagle County. VVU's request includes information that with the CPGP funding, they will be able to allocate additional funds toward tuition assistance (financial aid) to ensure that their student body is representative of the community. VVU's mission is aligned with Mountain Rec.

RECOMMENDATION: Staff recommend the use of the sport court at Edwards Field House to use for PE classes 2-3 times a week between January and April and Edwards Freedom Park April-June. Total grant award recommended to Vail Valley Unbound for FY24: \$2,125.

WORLD ACADEMY

Edwards Field House for three two-hour facility rentals including anti-gravity center, sport court, and community room for twenty students and three staff members during school hours. The total request from World Academy is \$210.

World Academy is a kindergarten through 12th grade online program within Eagle County Schools that aims to provide students who are looking for a unique learning path with a self-paced, challenging core content curriculum.

World Academy students spend most of the school week using technological platforms to complete schoolwork. Students are often alone, working at their own pace. We will measure impact formally by the percentage of students who attend, and informally by the responses shared by students because of this opportunity.

We are working toward building relationships and increasing face-to-face time between online students and teachers, engaging students in physical activity to offset the amount of time spent in an online platform, and becoming familiar with community resources. Our anticipated

outcomes include increased relational confidence between students and students/students and teachers, opportunity for students to engage with other kids for the purpose of having fun and being physically active and building strong connections within our school and community.

DISCUSSION: While World Academy is part of the Eagle County School District, it does not fall under the IGA. Students enrolled in World Academy have little interaction with each other or other students and this grant request would provide much-needed community building and recreation opportunities for this population.

RECOMMENDATION: Staff recommend that we award World Academy the full amount for staffing support. The total grant award recommended to World Academy is \$210.

- * For the purposes of this grant, "underserved" shall be defined as serving households earning 80% AMI or lower.

COMMUNITY ENGAGEMENT & FUNDRAISING REPORT -

LIZZY OWENS

Staff submitted a grant to the Gates Family Foundation for funds for the Eagle Pool; we will hear back in December whether our grant was awarded. While we did not move to the next step in the GOCO grant application process, the feedback we received was very positive and we were encouraged to apply again in October. Mountain Rec staff and Town of Eagle staff will be meeting later this month to incorporate the feedback received from GOCO staff. Staff submitted two grants to Eagle County Public Health & Environment for Fiesta Americas and the Eagle Pool, respectively, and both were denied.

Staff received 14 applications for the Community Partnership Grant Program, all of which have creative asks that will benefit the community.

Fiesta Americas is less than two weeks away, and we are getting ready and getting excited. With more than \$37,000 in sponsorship dollars, this event is free for the whole family with food trucks being the exception. MARKETING AND COMMUNICATIONS REPORT – EDDIE

CAMPOS

Marketing has been hard at work in preparation for our second annual Fiesta Americas on September 17th in Gypsum. Again, this year, Eddie took lead in overall festival branding, advertising, sponsor activation, and public relations. This year we've doubled the number of media buys, in an effort to spread the word and invite everyone across Eagle, Garfield, and Pitkin County across channels in Spanish and English. This festival is put on by representatives from the District and our partner, My Future Pathways. This is a great opportunity to connect with the community and we invite the board to attend, and volunteer if you are able to. Earlier in August, marketing focused on promoting the Sports Gear Swap, and awareness of the event increased over last year, resulting in a line out the door waiting to get into the Eagle Pool and Ice Rink on the first day of the event. Additionally throughout the month, marketing pushed the District's upcoming youth and adult sports leagues, Esports, as well as news of the Gypsum Rec Center Pool closure in September and the District having received the highest mark in its annual financial audit.

BUSINESS OPERATIONS REPORT – SCOTT ROBINSON

Staff have been invited to participate in a Property Tax Forum hosted by the VVP and Marchetti and Weaver on September 13th. The bulk of the discussion will focus on educating the community on the property tax formula (how we determine our property tax revenue based on assessed valuation, residential assessment rate and our mill levy) a report from Mark Chapin the Eagle County Assessor on the recent reassessment and presentations from Eagle County School District and Eagle County Government. Staff are working on high-level talking points in case we're asked to speak on Mountain Recreation's plans for FY24. Please know, these talking points will not be committing our board to a potential mill levy credit or no credit in 2024. That will be a decision for the board to make prior to the state deadline for certifying our mill levy for the 2024 budget. Speaking of deadlines, below are the two options for mill levy certification deadline which depend on if Proposition HH passes or not in November.

We need to provide a certified copy of our mill levy to the county:

If Proposition HH does not pass – December 15, 2023 If proposition HH passes – January 5, 2024

The forum is on September 13th from 10am-12pm at the Eagle County Room in the County Building in Eagle. All board members are welcome to attend!

Moving into 2024 we have two large contracts set for renewal. They include our contract with SmartRec and Decypher. Staff are planning to renew both contracts and are working through the logistics/negotiations at the moment. Due to the large scope of these projects, we need to have them renewed prior to expiring because if a switch is being made, staff need 3-6 months to execute the change in vendors. Both contracts are on track for renewal.

An offer has been made for the HR Manager position and staff are currently negotiating with the candidate.

EXECUTIVE DIRECTOR REPORT – TURE NYCUM

Whew – one month has passed by quickly. It's been a whirlwind of learning, meeting people and a lot of coffee – from my perspective it has been great to start becoming integrated into the Mountain Recreation community. SPORTS PROGRAMS - ADULT LEAGUES

August brought a great deal of joy to the community. We are wrapping up our summer adult softball leagues. We have finished the adult playoff bracket for our men's upper division and the other leagues will finish in the first week of September. We have received a lot of positive feedback about how our softball leagues have been running. It is good to hear the community giving us credit where credit is due. August also brought the registration opening of our Women's Hockey League. It never ceases to amaze me how awesome this program has grown to be. Registration opened on August 22 and was filled with 86 women in four days. It will be fun to watch the relationships that will be built in the upcoming months through this program.

SPORTS PROGRAMS - YOUTH LEAGUES

August was an exciting and stressful month in the youth sports league world. We reported to you last month that we are programming 837 kids across three sports this fall, the biggest program we have ever done. With that came challenges with scheduling and completing the jersey order. The sports team worked tirelessly to accommodate hundreds of requests and delivered on as many as we could. On the jersey front, we found that four weeks of lead time was difficult to deliver when the scope of the project was as big as this one. Most teams received their jerseys on the day of their first game, but supply issues are holding up some jerseys. Looking forward the sports team has discussed moving the registration period up a week to allow five weeks to deliver on jerseys, as we anticipate the big numbers to continue. The community has little compassion towards us when we don't deliver on the jersey order. We will work closely with the marketing department to help the community with this change.

Summer camp is over! My first summer went smoothly. We had a great team of returning staff and new staff who made it a success. 
EAGLE POOL AND ICE RINK INFORMATION – SHERVL STATEN

The Eagle Rink continued to host roller skating nights on Tuesdays from 5:30-7:30pm through August 21st. Participation numbers declined in August, and we were only averaging 2-3 skaters the last few weeks of the summer. Rec Kids Summer Camp wrapped up Eagle programming on Friday, August 4th.

The second annual Community Equipment Sports Swap took place on Friday, August 18th and Saturday, August 19. We were happy with the amount of donations that came in during the event. Staff had a lot of skiing equipment, hockey gear, baseball equipment, camping/fishing gear, kayaks, fitness equipment, clothing, soccer gear and about 20 bikes! There was a line at the facility on Friday evening when the doors opened at 4pm. Most of the items were picked over quick on Friday night with over \$1,600 going to the Mountain Recreation Foundation. We look forward to continuing to expand this great community offering!

Staff continued with EPIR maintenance projects in August and rallied additional staff to pull up the rink sport court on Wednesday, August 23rd. Three trees at the rink front entry were removed in August as they were unhealthy and dying. We also trimmed up the trees at the front entry that were beginning to impede the roof. The rink dashers were all cleaned and are looking brand new. The tile in both locker rooms have been professionally cleaned/sealed and every single light bulb in the ice rink is functional for the upcoming season! Rink start-up preparations began the last week of August with the Rink scheduled to open September 18th.

Fun Fact- "Registering for Women's hockey is like buying Taylor Swift Tickets". The MWHL women's hockey program registration opened on August 23 and filled with 90 women registered in 2 days! We are continuing to monitor the waitlist and will do our best to add a 7th team for our 20th Anniversary season!

August was a good month with transition to fall season. August had 2 birthday parties on Friday nights. August also had 35hrs of rentals and non-profit usage throughout the month. August Taekwondo classes had 16 kids on Tuesday nights and 15 kids on Wednesday nights. We will also be running an E-sports camp and Taekwondo camp the week of fall break, October 9-12. Red Canyon HS continued their yearly usage of the field house on Mondays-Fridays from 3-4pm. They will be using different spaces of the field house during this time as a pe class. ECCA and Edwards Elementary Schools will also be doing some School groups during the month of September for field house usage. Staff met with Vail Valley Unbound (non-profit K-1st grade elementary School) about field house usage during the fall, winter, and spring months. Staff is working with them on their usage and hopefully comes to fruition in the next couple months. Staff is finalizing winter schedules with user groups and any new users for the winter 2024-23 seasons. Staff met with the Edwards Ice Rink group to construct a plan for the winter 2023-24 season.

Edwards Freedom Park in August was busy with transition season from summer to fall. Regular programming for Mountain Rec youth football and soccer, Vail Valley Lacrosse Club, Vail Valley Soccer Club, Stash Lacrosse, La Liga Sundays, La Liga Masters, La Liga Women's, and Battle Mountain High School. No tournaments during the month of August but had the following special events (Mountain Youth on August 4, Gracious Savior Church on July 31-August 4, Summit County Search and Rescue training on August 11-19, 9/11 Memorial on September 11, Eagle River Watershed Council Group on September 22. The Vail Valley Soccer Club will also host their annual fall tournament September 29-October 1. They will use 4 fields in

Edwards and 3 fields in Eagle. Staff submitted information to Eagle County on the spray park renovation for a notice intent to begin the contract with Design Concepts. Mountain Recreation is waiting for the notice of intent and once that is finalized the reconstruction process can begin. Staff from Mountain Recreation and Eagle County are positive construction could begin in spring of 2024 with an anticipated opening sometime in summer 2024. Irrigation systems are still currently running on one pump and motor but everything has been running smoothly and the complex looks great!

GVPSUM RECREATION CENTER INFORMATION – LAUREN SHIVELY

We started off August with a fun staff pool party at the Gypsum Creek Pool. Sheryl led the charge for that event, ordering Ekahi and keeping the pool open late for staff on August 4th. We had a good turnout, with both full-time and part-time staff attending. It was a great time, and we are looking forward to keeping that tradition going next year! The Gypsum Creek Pool visitation numbers continued to stay steady with hot temps in August. GC Pool remained open on weekends through Labor Day weekend.

The flow of the Gypsum Recreation Center has changed a bit with kids going back to school. We no longer have multiple summer camps happening during the day, and we do not have our regular teenage kids visiting to play basketball or volleyball. With it still being warm outside, pickleball has not yet returned to indoor play. It has been very quiet around the facility, until 4pm. At 4pm, we have a rush of kids signing in for gymnastics, teenagers arriving to play drop-in basketball, and adults arriving to workout after work. With the issues we faced last year in terms of teenager behavior, we were much more proactive this year, making sure that staff were prepared to take backpacks at the front desk and providing wrist bands for those playing basketball. We have kept ensuring that only people over 13 are upstairs and that the students on the basketball court are behaving. It has also been awesome to see 30+ adults show up for drop-in basketball on Wednesday nights!

Prior to the new school year starting, Lauren met with each staff member to complete their annual reviews. This was great timing to give them feedback on where they can see room for growth for them individually, while also letting them know what they did great over this past year and summer. It also was beneficial to set the expectations for the new school year one-on-one with each of them. We made a few changes to the schedule, so there may be different faces at different times at the Front Desk.

Staff began prepping the pool deck for the new pool deck installation. It was satisfying to deep clean underneath the old pool deck that was laid. The housekeeping staff really stepped up to help detail the drains and floor. We are all excited to see the new pool deck once it is installed. In addition to a new pool deck, we are repainting the walls, installing a new slide pad for the small slide, and hoping to install new artwork on the walls.

Lauren worked with Taylor Slaugh from the Town of Gypsum to receive some local photographs of recognizable spots in Gypsum.

The Gypsum Creek Pool has continued to run smoothly this month. Since it is only open on Saturday and Sunday, it is a simple operation. The outdoor pool closed the beginning of September, so we have no pools open for the entire month of September.

We're excited to join the Mountain Rec Spanish class! We meet in Edwards on Tuesday morning. It is lovely to get together with other Mountain Rec staff to practice the language. We're excited to be able to put it to use at the front desk with our community.

Lauren worked with two companies to put a proposal together for the Town of Gypsum to remove the Gypsum Rec Center fireplace and purchase new furniture for the area. The Town Manager will receive insight from the Town Council and provide feedback.

MEMBERSHIPS / DAILY ADMISSIONS

The Gypsum Rec Center had a total of 2,985 memberships at the end of the month, which is 130 less than the end of last month. This is expected, as we normally lose membership throughout the summer, and they pick back up in the fall. We had 9,703 membership scans throughout the month, which is 883 more than last month. We brought in \$5,272 in daily admissions through August.

ON DECK

Mike and Lauren have begun planning the Rec or Treat event! We are excited to hold this again as it was a huge success last year. We will be reaching out to various community organizations to ask for their participation, as well as program areas within Mountain Recreation.

With the pool being closed in September, we will not be hosting any pool parties. Our gymnastics parties have picked up recently.



PROJECT UPDATES REPORT - 9/11/23

EAGLE POOL REPLACEMENT - SCOTT RUFF

The EPIR executive planning committee, comprised of Mountain Recreation and Town of Eagle staff, hosted design team interviews for the Eagle Pool on Wednesday, September 6th at the Brush Creek Park Pavilion with the help from Dynamic Program Management. The firms interviewed were Essenza Architecture, Land and Shelter Architecture, and OLC Architecture. Each firm was given 1 hour and 10 minutes to introduce their team, present an interactive vision for the new pool construction, and take questions from the interview panel. The interview committee selected OLC to be our design team and our owner's representative has notified them of our selection.

CM/GC interviews will take place on Friday, September 15th with Dynamic Program Management coordinating these efforts. Five firms submitted proposals, of which three will be interviewed – AD Miller, JHL Constructors, and RA Nelson.

The executive planning committee met on Thursday, September 7th to begin setting "guardrails" for the next steps once the CM/GC is brought on board at the end of September. The team discussed the importance of coming in at or under budget, having an aggressive timeline, and receiving community feedback.
